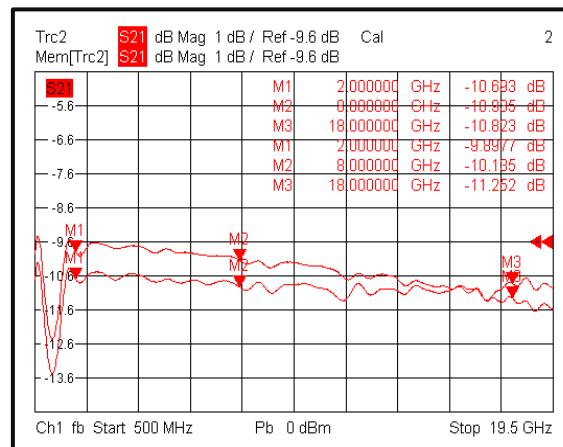

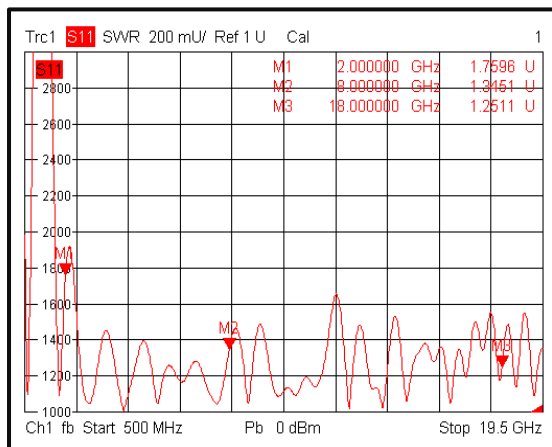

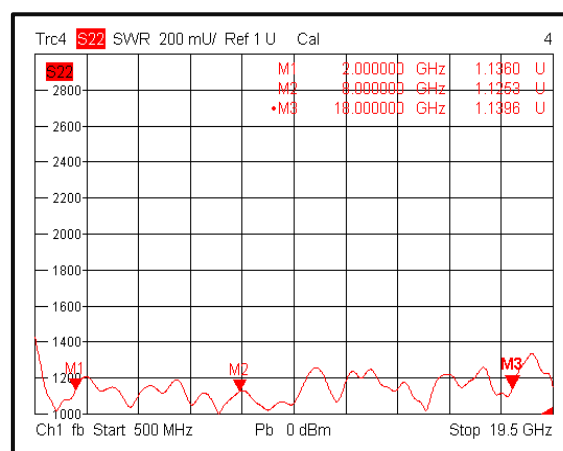
Loss & Amplitude Imbalance



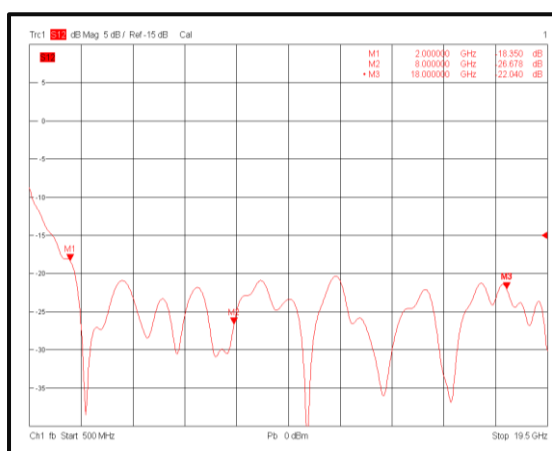
Input VSWR



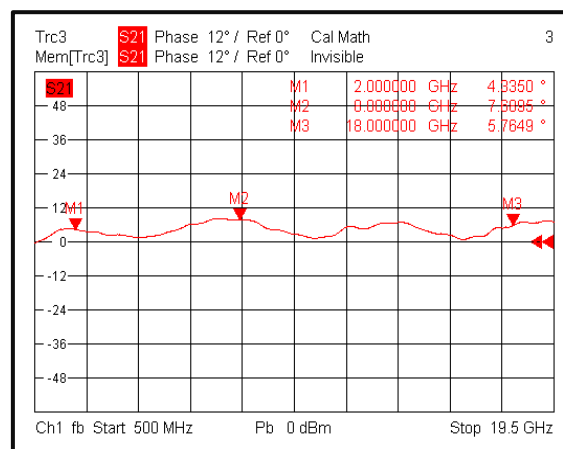
Output VSWR



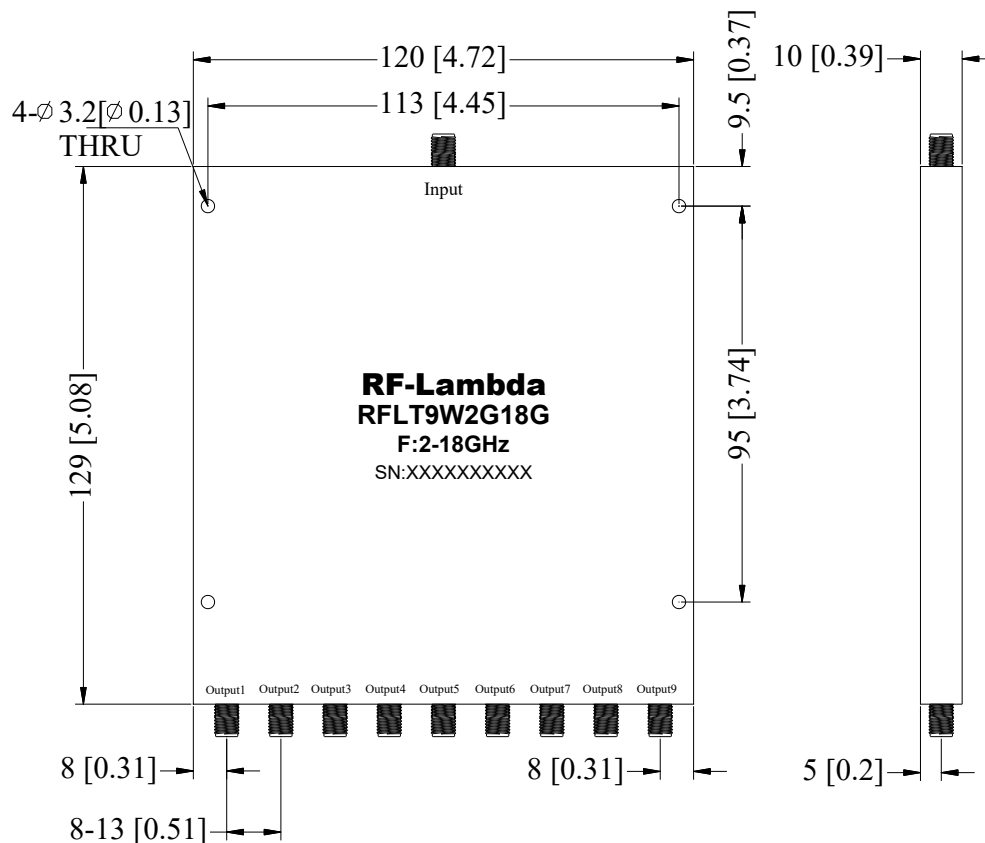
Isolation



Phase Imbalance

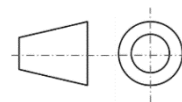
